## Application for ELC Bursary Scholarship

### Applications for 2026+ close 15 September each year

#### SUMMARY OF ELC BURSARY SCHOLARSHIP OFFER

The Covenant Christian School ELC Bursary Scholarship is designed to offer like-minded families a placement at the Preschool for one or more (ie. eligible siblings), where they may not otherwise have the opportunity to apply due to hardship or extenuating family circumstances.

Covenant Christian School reserves the right to decide the merits of an application and determine what, if any, bursary scholarship will be offered. No correspondence will be entered into once a final decision has been made on an Application for ELC Bursary Scholarship form.

To be eligible to be considered for a Bursary Scholarship:

- the family must not currently have any children enrolled at Covenant Christian School;
- the family must not already have submitted an Enrolment Application form for Covenant Christian School ELC;
- the family must demonstrate some form of financial hardship and/or extenuating family circumstances; and
- children must be Australian citizens or permanent residents. Temporary residents may be eligible, depending on their class of visa.

Dependent on individual & family circumstances, the scholarship may be offered as:

- a set dollar amount, to be redeemed against a family's tuition account during the term of their child(ren)'s enrolment; or
- a percentage over a period of time (maximum of 50% per ELC Session enrolled), to be redeemed in full during that set period of time.

The Scholarship may:

- apply to more than one student, provided that siblings are eligible for enrolment;
- be used towards tuition and related expenses on the scholarship family's school tuition account (eg. tuition fees, uniforms) over the duration of their child(ren)'s enrolment at the school;
- only be used for credit against the scholarship family's Covenant tuition account;
- not be redeemed for cash or transferred to another family.

Where a scholarship is awarded:

- recipient students must commence full-time enrolment in Kindergarten at Covenant Christian School within 12 months of the formal date of notification and remain enrolled for at least one full year otherwise any bursary offered is to be repaid to the School;
- the identity of recipient students and their families will be kept confidential; and
- the value and terms of the scholarship offered will be kept confidential.
